Vendor Registration/Set-Up

- Registration is from 6:00 am to 8:00 am on Saturday. Overnight security will be provided however, Wamego Chamber of Commerce is not responsible for lost or stolen items. Vendors must be ready to receive guests at 10:00 am on Saturday and 12 noon on Sunday.
- Vendors must remain on-side and serve samples until 5:00 pm on Saturday and 4:00 pm on Sunday.
- There is no vendor fee to participate.

Vendor Expectations

- All vendor representatives must be 21 years of age or older
- Vendor representatives must maintain sobriety while participating in the festival. Any vendor representative deemed intoxicated during the festival shall be subject to ejection.
- Vendor representatives shall conduct themselves with appropriate behavior at all times. Activities by a vendor representative that endanger festival attendees, festival staff or festival vendors, or any activity which is contrary to Kansas law may subject the vendor representative or the attending vendor to ejection from the festival at the sole discretion of the Wamego Chamber of Commerce staff.
- **Please serve responsibly during the festival. Vendors must limit individual sample size to 4 oz. for beer and cider and 2 oz. for wine.**
- Attendees who appear intoxicated or do not have a wristband will not be served. Alert Chamber staff or security personnel if needed.

Marketing and Logistics

- Promotion of your product may only occur within the confines of your booth.
- Photos supplied by the vendor may be used in promotional material and social media.
- Photos or video taken by Chamber staff or Tulip Team may be used in promotional material and social media.
- The vendor agrees to work with the Chamber to obtain necessary sampling paperwork.

This will be the inaugural year for this exciting new addition to this long-standing festival. Our goal is to enhance this successful festival that includes live entertainment, children's activities, delicious foods and bountiful shopping opportunities!

We would like to feature a variety of beer, wine and cider from the region. In order to facilitate this, we are asking vendors to provide free samples to patrons. Wineries will also be allowed to sell wine by the bottle per ABC regulations. The tent will feature sampling for guests age 21+.

The tent will be located on the South Tennis Court with a controlled gate and an admission price. Seating will be provided to patrons as well as a bar for purchase of beer, cider or wine by the glass. Outside food will be allowed to be brought into the tent. Sample cups and ice will be provided for each vendor as well as a table, and two chairs per vendor booth. Vendors MAY provide their own sampling cups as long as they comply with pour limits.

Participating vendors will be required to be open from 10 am to 5 pm on Saturday, April 23rd and 12 noon to 4 pm on Sunday, April 24th.
